Familiarisation Programme for Independent Directors

(In terms of Regulation 25(7) of the Listing Regulations)

Background

Practices followed by the Company on a continuous basis

- All the Independent Directors are made aware of their roles and responsibilities at the time of appointment through a formal letter of appointment, which also stipulates various terms and conditions of their engagement; nature of the industry in which the company operates, business model of the company, etc., through various programmes and details of such familiarization programmes are required to be disclosed on the company's website and a web link thereto shall be provided in the annual report.
- Atleast one Board Meeting in a year has a detailed strategy session with the senior management team of Pushkar Banijya Ltd. The members of the Management team of the company make presentations to the Independent Directors which inter alia covers the industry scenario, strategic priorities for and the business model of the Company.

Other familiarisation programmes which the Company may conduct from time to time

• The Company may conduct introductory programmes when a new Independent Director is inducted on the Board of the Company.
